ALL APPLICATIONS ARE DUE JANUARY 25th BY 6:00 PM. Applicants will be asked to meet with Council on **FEBRUARY 10TH at 6:00 P.M.** to briefly discuss (2 to 3 minutes) their reasons and qualifications for seeking appointment and what they would hope to accomplish during their term, if appointed. Appointments are scheduled to be made by the City Council on February 24th. Terms will begin March 2010. All applicants must be registered voters of the City of Encinitas.

Please note: Applications submitted are a public record and copies will be provided to anyone requesting such. If appointed, Statements of Economic Interest forms are required to be filed with the City. These statements are also a public record. The City's ordinance limits absences from a commission meeting to three in a 12-month period, or a quarter of the meetings held.

PLANNING COMMISSION – Three (3) Appointments to be made;

Terms are expiring for the two representatives of Leucadia, New Encinitas, Olivenhain. Applications will be accepted from residents living in these three communities only. The Planning Commission is a five-member board; one member from each Community area. Members of the Planning Commission must have resided as a registered voter in the Community area for which appointed for no less than six months prior to appointment, and maintain residency and voter registration in the Community area for which appointed. Members serve staggered, two year terms. The Planning Commission studies and report to the Council any matter referred to it by the Council. This Commission makes recommendations to the Council and is authorized to make final determination on several applications provided in the Municipal Code.
